

## Monnet Foundation initiated Health Camp in Villages

**Raipur (Chhattisgarh), 1<sup>st</sup> April '2013:** Monnet Foundation, a CSR arm of Monnet Ispat & Energy Limited (MIEL) organised a health camp in Serikhedi and Tulsi villages for malnourished children under the supervision of Dr. Neeta Karnavat (Paediatric), Dr. Kavita Lal (Paediatric) & Dr. Surjeet Singh (ENT) from Bhim Rao Medical hospital.

As a regular practise, Monnet Foundation organises health camp every month because it firmly believes that ensuring proper healthcare facilities for a family is equally important as ensuring financial stability.

Monnet Foundation believes that special care of the children needs to be taken from their birth till the age of 6 years as these years are considered to be the building block of one's life. Lack of proper diet and nutrition leads to slow development & malnutrition amongst children.

**The Foundation, during the process found that there were many malnourished children in the villages. Therefore, around 375 children were diagnosed, and around 89 malnourished children were advised Protein, Iron and Calcium intake. Moreover, parents of these villages were counselled for providing healthy diet to their children and also on maintaining personal Hygiene like brushing, bathing every day.**

Mitanin - Sarpanch, Anganbadi personnel actively participated in the health camp and encouraged the families of these villages to provide healthy intake to their new-borns.
